The following statements are binding upon the manufacturer per the Defense Standardization Manual 4120.24-M:

- c. The QPL is effective as of the date of this letter and applies only to products or processes


produced in the plant specified in the letter of notification.

d. The QPL applies to amendments or revisions of the specification, unless otherwise notified.

e. The QPL applies only to products or processes identical to those qualified or to products defined in the family of products granted qualification coverage. The supplier must inform the qualifying activity in advance of any intended change to the product or processes and must provide a complete description of the change. Failure to notify the qualifying activity of any change is cause for removal from the QPL regardless of the extent of the change.

f. Manufacturers must comply with a requirement for retention of qualification to remain on the QPL. Failure to comply is sufficient cause for removal from the QPL.
